Dear California Postal Employees:

The U. S. Post Office is an important partner for all California county election departments. Use of Vote-by-Mail ballots has steadily increased over the years and for the November 3, 2020 election all registered voters will receive their ballot in the mail. Your work is critical as ballots are mailed to voters in early October and voted ballots are returned by mail to be counted in the November 3, 2020 General Election.

I want you to know that your efforts are truly appreciated. We appreciate that you are trained to prioritize all mail with an election logo. County election officials will be mailing County Voter Information Guides approximately the last week of September and the majority of ballots on October 5th. We especially value your attention to each ballot as they pass through your hands and find their way to voters. Voted ballots are returned in distinctive envelopes to county election offices, which must be postmarked on or before November 3rd. It is important that we also recognize that your work related to address changes is an important part of our efforts to keep our voter records accurate.

Our democracy literally depends on your hard work and commitment to your job. Thank you for your service. Thank you for your hard work. Thank you for being such an incredible partner in our work.

Please know that we will do everything that we can to be sure that this election and all elections will be conducted with integrity.
