**ELECTION IRREGULARITIES REPORT**

Requires the Secretary of State (SOS) to establish a uniform report format that elections officials would use to document election incidents and voting irregularities during a regularly scheduled statewide election. The report submitted by election officials shall be made publicly available on the SOS Website.

**RUNOFF BALLOT: SPECIAL ABSENTEE VOTERS**

Requires local elections officials to prepare a special runoff ballot for each primary, special or general election to allow votes of special absentee voters, including military personnel who are temporarily living outside of the United States to be counted if there is a runoff election for any of the offices in that election. The completed special runoff ballot must be received by the elections official by the close of polls on election day.

**LOCAL GOVERNMENT: ORGANIZATION: ELECTIONS**

Requires the board of supervisors or the city council, to take action, to order and place an item on the ballot, within 45 days of notification by a local agency formation commission that it has made a decision that will require an election. Requires the elections official to place the item on the ballot at the next regular election if the board of supervisors or the city council fails to take action within the specified time period. Becomes effective January 1, 2011.

Requires that a member of the precinct board provide written notification to a voter who has declined to state a party that he or she may request a ballot of a political party that has authorized a voter not registered with that party or a nonpartisan ballot. Requires the notification to list each political party that has authorized a voter not registered with that party to vote the ballot of that party.

**WRITE-IN CANDIDATES FOR JUDICIAL OFFICE**

Requires that a write-in candidate for the office of superior court judge include on the statement of write-in candidacy his or her compliance with certain eligibility provisions for a judge of a court of record.

**SPECIAL ABSENTEE VOTERS: RECOUNT OF BALLOTS**

Requires 1) a county elections official to count a special absentee voter's ballot when it is received on or before the 6th day after the election 2) an elections official not later than 30 days after the certification of each election to report to the Secretary of State (SOS) information regarding special absentee ballots including the number of applications for special absentee ballots, the number of special absentee ballots delivered, and the number of special absentee ballots received before and after election day and 3) that not later than 60 days after the certification of the election, the SOS shall compile the information received and report to the appropriate policy committees of each house of the Legislature.

**ELECTION DAY VOTER REGISTRATION**

Authorizes a person who qualifies to vote in the state to register or reregister at the office of local elections commencing on E-14 and continuing through election day. Provides that a person who registers on election day may cast a provisional ballot. Requires local elections officials to compile a list or index of voters who registered or reregistered to vote pursuant to such provisions and to conduct a review of the names on the list or index and cancel any duplicate voter registrations that may exist. Also makes conforming changes to provisions relating to provisional ballots. **Becomes operative January 1, 2012.**

**ELECTED OFFICIALS: RESIDENCY REQUIREMENTS**

Requires that a person elected to the Legislature, or a public office in a county, city, or school district, maintain his or her place of residence within the jurisdiction within which voters are qualified to vote for the office during his or her term of office. Requires a person who violates such provision to immediately forfeit his or her office and would disqualify the person from holding elected office for a period of 3 years. Provides that such provisions would apply retroactively to all persons holding a public office, as specified, under terms of office that commence on or after November 2, 2010 and members of the Legislature whose terms commence on or after December 3, 2012. Imposes misdemeanor penalties on any person who violates these provisions.

**ALL-MAILED BALLOT ELECTIONS: YOLO COUNTY**

Authorizes a pilot program in Yolo County that would allow elections, other than statewide primary or general elections or special elections to fill a vacancy in a state office, the Legislature, or Congress, to be conducted as all-mailed ballot elections under specified conditions. **Operative until December 31, 2016.**

**DEMOCRATIC PARTY: RULES AND BYLAWS**

Requires that the elements and practices to select delegates and alternates be the same as set forth in the standing rules and bylaws of the Democratic National Committee and the Democratic Party of the state, as specified. Expands participation in the delegate selection process to a voter who declined to state a party affiliation but requested to vote the ballot of the Democratic Party at the partisan primary election. Requires the Democratic Party to post any rules and bylaws relating to these provisions on its Internet Web site. Also revises various timeframes relating to presidential primary elections.

Authorizes county and city elections officials to establish procedures that would allow a voter to opt out of receiving his or her sample ballot and other ballot materials by mail and instead obtain them via electronic means such as e-mail or accessing them from a county's or city's Internet Web site under specified conditions.

**VOTING BY MAIL: REPLACEMENT BALLOTS**

Deletes the requirement that a voter who requests a replacement vote by mail ballot provide a statement under penalty of perjury that he or she has failed to receive, lost, or destroyed an original ballot. Specifies that if an original ballot is received from a voter who has requested a replacement vote by mail ballot, that original ballot shall be held until such time as it can be determined that the voter does not intend to return the replacement ballot. Also specifies in no event may more than one ballot of a voter be processed and tallied in an election.

**COUNTY BOARDS OF EDUCATION: ELECTION**

Deletes existing provisions relating to the selection of the county board of education in a chartered county and requires that, if, on January 1, 2011, a county charter provides for an appointed county board of education, board members in those chartered counties shall be elected beginning in the 2014 direct primary and subsequent primary elections.

**POST CANVASS AUDIT – PILOT PROGRAM**

Authorizes the Secretary of State to establish a postcanvass risk-limiting audit pilot program in 5 or more voluntarily participating counties for the purpose of verifying the accuracy of election results. Requires the county to conduct an audit of one or more contests in each election after the tabulation of the unofficial final results or the completion of the official canvass for the election. Requires the audit be conducted in public view and by manual tally.

**RECALL PETITIONS**

Provides that if 500 or more signatures are submitted to the elections official, the elections official may verify using a random sampling technique, either 3% of the signatures submitted or, 500, whichever is greater. Prescribes the procedures if a vacancy occurs in an office after a recall petition is filed against the vacating officer. Specifies that a person who was subject to a recall petition may not be appointed to fill the vacancy in the office that he or she vacated and that person may not be appointed to fill any other vacancy in office on the same governing board for the duration of the term of office of the seat that he or she vacated.

Authorizes a court upon finding a person guilty of violations, to issue an order prohibiting a person, for a period of up to 5 years, from receiving money or other valuable consideration for 1) assisting another person to register to vote by receiving the completed affidavit or 2) for gathering signatures on an initiative, referendum or recall petition. Also allows a person to seek reconsideration of the court's order and imposes civil penalties for a violation of a court order.

**Requires a voter, who is a member of a protected class to file a written claim with a county office of education, a school district, or a community college district where a violation of the CVRA is alleged, prior to filing an action in superior court. Provides that if, the county office of education, school district, or community college district fails to respond to the claim within 30 days the claimant may immediately file an action. URGENCY.**

**Authorizes the board of supervisors to make a determination within 30 days of a vacancy on whether to fill a vacancy in the office of United States Representative in Congress, State Senator, or Member of the Assembly by using a prescribed instant runoff voting method, except that if 2 or more counties are affected, all counties would have to agree to use the instant runoff method. Requires every affected county to conduct a voter education and outreach campaign in every language a ballot is made available to voters in the county through public service announcements.**

Requires that claims to reimburse counties for net costs incurred by them in complying with the voter registration provisions, including the provisions authorizing voter registration by mail and voter outreach programs be submitted to the Controller by February 15 in the year following the fiscal year in which the costs were incurred. Repeals provisions that provide for a revolving fund to purchase ballot paper and punchcards. Provides that the precinct board shall post outside of the polling place only the total number of people who voted, in cases where fewer than 10 voters cast ballots on machines on which the results are tallied at the precinct and posting the results may violate a person's right to cast a secret ballot.
