Voting Modernization Board (VMB) – Proposition 41 bonds	To assist counties in the purchase of modern voting systems. Counties are required to match funds on 3 to 1 basis – for every \$3 the state spends, the county must spend \$1. County may use HAVA Section 102 or 301 funds as their matching portion.	Allocation formula based equally upon the number of persons eligible to vote, the number of registered voters, the number of voters who voted in the last four election cycles, and the number of polling places, and the number of persons eligible to vote, as derived from data from the March 2002 Primary Election.	Payment request with detailed invoices required.	Funding Award issued upon approval by the VMB of a county's Project Documentation Plan to modernize their voting equipment.
