Dear Governor Brown;

The California Association of Clerks and Elections Officials wishes to advise you that it supports AB 1535 which contains provisions requested by our Legislative Committee. The bill provides clarifying language on the requirements for requesting removal of a voter's name and signature from a petition and specifies the residency requirements for military and overseas voters. Both of these changes benefit voters and make it more likely that the voter's wishes and intent can be honored. Further, the ability to consolidate in vote by mail elections, under certain conditions, offers cost savings and efficiencies to the districts and for administration of elections.
