**AB 554 (MULLIN) -SUPPORT**

Dear Assembly Member Mullin:

The California Association of Clerks and Elections Officials is pleased to advise you of our support for AB 554, which expands the provisions for the use of minority language proficient legal residents to serve as poll workers to include high school students between the ages of 16-18 years old. Students, meeting all the criteria for serving as non-voter poll workers, were excluded from the original legislation which only provided the opportunity to serve as a poll worker to those permanent residents over the age of 18.

We are supportive of all efforts to increase the level of civic engagement and participation of California's youth and see this as a positive step to that end.
