Call to Order - President Gail Pellerin opened the meeting at approximately 1:06 PM

Roll Call – Secretary Dean Logan called the roll and distributed the Attendance Log

**Approval of Minutes** – Secretary Dean Logan distributed minutes of the July 19, 2011 Board of Directors meeting. MOTION to adopt (Becky/Steve Wier) APPROVED.

President's Report (Gail Pellerin)

- **Correspondence:** Norma Logan thank you. Get well letter will be sent to Kathie Moran (Colusa County) who broke her leg.
- EAC Standards Board selection: Neal Kelley recommended as the California representative for local government officials (Deborah Seiler/Lindsey McWilliams).

**Vice President's Report** (Cathy Darling Allen) – Membership report: As of September 16, 2011 there were 845 active profiles, 121 Principal Members, 420 Deputies and 40 Associates. Total dues paid members 581. There are 125 member profiles associated with the County Recorders Association of California (CRAC).

### Treasurer's Report (Neal Kelley)

- Multi-page handout/reports distributed and filed
- Cash Balance report (emailed out to Board prior to meeting)
- Budget Proposal:
  - **Neal Kelley:** Overview; addressed concerns raised at Annual Conference; partially a cell calculation issue. Discussion on lobbyist costs for Clerks and Clerks of the Board.
  - Last year our revenues exceeded our expenses by a small amount.
  - Placed \$30,000 in reserves pending additional action.
  - Insurance: \$2,500 strictly a crime bond (only covers theft); little background; no director or officers liability insurance. Estimate for coverage is \$1,500 for \$500,000 liability and would not cover theft. Austin Erdman sees this as a critical issue. \$1,500 included in the proposed budget; recommends \$1 million umbrella for officers/directors insurance.
  - o Move to adopt budget. (Austin/Becky) APPROVED
  - IRS Filing Extension; will be filed in November.
  - Cash reports do not reflect full cost of Annual Conference.
  - ~\$90,000 checking; ~\$150,000 in savings.

  - 1. Clerk of the Board (John McKibben) handout for July and September; next year will be sponsoring statewide electronic Form 700

  - 3. Elections (Deborah Seiler/Jill LaVine) active session; more bills proposed and more chaptered than in typical sessions.
    - SB6 clean-up did not get through (AB1413). Michael Wagaman (Speaker's Office) attended the last Leg meeting for further discussion; potential for urgency legislation in January. Discussion of CCROV approach; statewide standards common verbiage/abbreviations, etc.;
    - No movement on Central Committee reform. Continuing discussion; possible exemption from preparing certificates of election; moving to four year terms aligned with Presidential Election years;
    - Several bills that are currently sitting on the Governor's desk. Online registration; party contributor notification; personal identification on ballots; VBM returns; postmark on VBM returns;
    - Discussion on mandates/SB90 claims, etc. Deborah suggests possibility of looking at legal action;
    - Meeting locations for 2012. Attendance in Southern California has not been good. Consideration of resuming meeting only in Sacramento. Discussion on formalizing the composition of the Legislative Committee;
    - Candice Grubbs/Laurie Cassady (Butte County) proposal to CSAC for the state to pay proportionate share of election costs. Presented by Deborah. Steve Wier is supportive. Discussion. Lindsey McWilliams referenced code section exempting School Districts from VBM costs. CSAC has indicated they are unlikely to take this on. Strategic positioning vs. likelihood of it getting passed. Consensus was to merge this issue with a White Paper identifying legislative efficiencies/cost saving suggestions.
