<b>AUTHOR:</b>	Hernandez
<b>INTRODUCED:</b>	02/11/2015
<b>AMENDED</b>	02/18/2016
<b>STATUS:</b>	02/18/2016 In Senate. Re-referred to committee on E & C.A.
<b>CACEO POSITION:</b>	To be discussed
<b>SUMMARY:</b>	Deletes the requirement that the ordinance describes the boundaries, and number, of each legislative district and would instead require the legislative body, or the proponents of the initiative measure, to prepare a proposed map describing the boundaries and numbers of the legislative districts after the ordinance is passed or enacted, as specified. Requires a legislative body changing from a from district method of election to a by district method of election, or adjusting the district boundaries, to hold public hearings on the change, as specified. Makes numerous technical nonsubstantive changes to these provisions. Requires the districts to comply with the applicable provisions of the federal Voting Rights Act of 1965. Extends existing law that authorizes the legislative body of a city, as specified, to adopt an ordinance that requires the members of the legislative body to be elected by district or by district with an elective mayor without submitting the ordinance for voter approval, regardless of its population.

<b>SUMMARY:</b>	Amends existing law which prohibits the use of an at-large election in a political subdivision if it would impair the ability of a protected class to elect candidates or otherwise influence the outcome of an election, and which provides that certain voters may bring certain actions in superior court. Prohibits the use of a certain district-based election if it would impair the ability of a protected class to elect candidates of its choice. Requires a court to implement specified remedies in certain cases.

<b>SUMMARY:</b>	Permits a candidate for Member of the Legislature to file a statement with the Secretary of State in which the candidate voluntarily agrees that, if elected, he or she will continue to reside within the district from which he or she was elected during his or her term of office. Authorizes the Secretary of State to post on his or her Internet Web site voluntary statements of continuing residency filed with the secretary, as described.

<b>SUMMARY:</b>	Authorizes a voter to take a photograph or digital image of his or her marked ballot and distribute or share that photograph or image using social media or by any other means, unless the voter does so for certain prohibited purposes. Exempts these acts from the criminal and civil penalties in existing law. Repeals a duplicate provision. Exempts from a crime in existing law a person examining or soliciting a voter to show a photograph or digital image of his or her marked ballot using certain means.

<b>SUMMARY:</b>	Requires that a response to a written request for public records that includes a denial of the request to be in writing regardless of whether the request was in writing. Requires that written response additionally to include a list that contains the title or other identification of each record requested but withheld due to an exemption and the specific exemption that applies to that record.

<b>SUMMARY:</b>	Authorizes any person to return the vote by mail ballot and specifically authorizes a paid or volunteer worker of a general purpose committee, controlled committee, or any other group or organization at whose behest the designee is performing a service to return an individual's vote by mail ballot. Prohibits a person designated to return a vote by mail ballot from receiving any form of compensation, as defined, based on the number of ballots that the person has returned and prohibits an individual, group, or organization from providing compensation on this basis.

<b>SUMMARY:</b>	Authorizes the governing body of a local agency to permit a candidate for nonpartisan elective office in the local agency to prepare a written statement for electronic distribution. Requires the statement to be posted on the Internet Web site of the elections official, permit the statement to be included in a voter's pamphlet that is electronically distributed, and prohibit the statement from being included in a voter's pamphlet that is printed and mailed to voters. Requires the elections official to provide a Spanish translation to those candidates who wish to have one. Requires the notice in the heading of the first page of the voter's pamphlet, in certain circumstances, to specify that additional statements are available on the Internet Web site of the elections official.

Requires that a person affirmatively agree to become registered to vote during a transaction with the department in order for his or her records to constitute a completed affidavit of registration.

<b>SUMMARY:</b>	Prohibits a State Senator or Member of the Assembly who decides to resign from office before the expiration of his or her term from subsequently using campaign funds held in trust for any purpose other than paying outstanding campaign debts or reasonable expenses. Amends the list of specified purposes allowable for the use of surplus campaign funds to include the payment of expenses to hold a special election to fill the vacancy created by the Member's resignation. Requires the former Member to pay from his or her surplus campaign funds such election-related expenses, to the extent he or she has funds available to do so. Provides that once election-related expenses are paid, the use of excess surplus funds to charitable purposes would be limited. Provides that a member who, after deciding to resign, uses campaign funds for purposes other than those authorized in that circumstance shall be personally liable for expenses to hold the special election.

Requires a county that conducts such an election to report certain information to the Legislature and the Secretary of State regarding all-mailed ballot elections. Requires the Secretary to report certain information regarding the success of such elections to the Legislature and a task force to review such elections.

<b>SUMMARY:</b>	Requires a homeless shelter that registers a person to vote to keep a record of the person it has registered to vote, including certain information about the person, and to transmit that information to certain government entities at least once per year. Authorizes an applicant who is a homeless individual to list the shelter, public space, cross street, or post office where he or she is living as his or her address on a driver's license or identification card.

<b><u>SB 958</u></b> County of Los Angeles Citizens Redistricting Commission	
<b>AUTHOR:</b>	Lara

<b>CACEO POSITION:</b>	To be discussed
<b>SUMMARY:</b>	Establishes the Citizens Redistricting Commission in the County of Los Angeles, which would be charged with adjusting the boundary lines of the districts of the Board of Supervisors of the County of Los Angeles. Provides that the commission would consist of 14 members who meet specified qualifications. Requires the commission to adjust the boundaries of the supervisorial districts in accordance with specified criteria and adopt a redistricting plan, which would become effective 30 days following its submission to the county elections official. Makes legislative findings and declarations as to the necessity of a special statute for the unique circumstances facing the County of Los Angeles.

Extend the time a local election official is required to determine the total number of signatures affixed to a petition, and the time the official is required to determine the number of qualified voters who signed the petition after receiving notice from the Secretary of State.

Requires a commission to report to the governing body its findings on the need for changes, as specified.

Requires in such a county, the county charter to provide the expenditures for the governing body and its staff may not exceed a specified formula. Extends these requirements to a general law county with the same population factors.
