SUMMARY:	Establishes an Internet Voting Pilot Program under which a county may offer Internet voting as an additional method of voting in a local election held within the county, provided specified conditions apply. Requires, before a county may conduct a pilot program, the county must test the program, as specified. Requires the Secretary of State to certify and Internet voting system before it may be used by a county in conducting a pilot program. Requires in order to certify the Internet voting system, the Secretary of State must conduct a top-to-bottom review of the system and report on the system's accuracy, security, integrity, efficacy, and accessibility. Provides that if a county conducts a pilot program, the county must evaluate the program and the county's experience with the voting system and to report thereon to the Legislature and the Secretary of State.

SUMMARY:	Requires that a write-in candidate for a voter-nominated office, in addition to being one of the top two vote-getters, receive votes at the direct primary election equal in number to at least 1 percent of all votes cast for the office at the last preceding general election at which the office was filled in order for his or her name to be placed on the general election ballot as a candidate for that office. Becomes operative only if ACA 9 of the 2013-14 Regular Session is approved by the voters.

Requires the Secretary of State to publish those procedures and guidelines on his or her Internet Web site, and report to the Legislature on the readiness of the state to hold elections during or following a natural disaster or other state of emergency, as specified.

Requires the elections official to cancel the affidavit of registration of each person listed in a statement, as specified.

Provides that the applicant's signature shall not be required. Prohibits a person from applying for a vote by mail voter's ballot by telephone using the name of, or on behalf of, another person.

Provides that a nonvoter appointed to serve as a precinct board member is prohibited from serving as or performing the duties of the inspector of a precinct board, or from being used by the precinct board to tally votes.

Extends the time a local elections official is required to determine the total number of signatures affixed to a petition to 10 days. Extends the time a local elections official is required to determine the number of qualified voters who signed the petition to 35 days after receiving notice from the Secretary of State that the petition has received the signatures needed to declare the petition sufficient. Additionally extends the time an elections official is required to verify the signatures on a petition to 35 days. Provides that the provisions of this act take effect January 1, 2014, and apply to any initiative or referendum petition for which the Attorney General issued a circulating title and summary on or after October 2, 2013.

Requires the county elections official to cancel the affidavit of a registration of a person imprisoned or on parole for a felony conviction whose name, address, date of birth, and the last four digits of his or her social security number, if available, are the same as reported on the court clerk's statement.

Provides that these provisions do not apply to a primary election for a voter-nominated office that is a state elective office if the candidate who receives the highest number of votes cast for the state elective office is declared elected. Provides that if a candidate for a nonpartisan office at a primary election receives a majority of all votes cast for that office, the candidate shall be elected to that office, and the office shall not appear on the ballot at the ensuing general election.
