SUMMARY:	Provides procedures governing aspects of statewide election recounts to include the storing of sealed ballots, regulations regarding the charges for conducting a manual recount, the Governor or Secretary of State, to order a recount and the method of the recount, a state-funded manual recount of votes for a office and a statewide ballot measure, and the approval of voting system prior to any election by the Secretary of State, and approval of a change to a noncompliant voting system.

SUMMARY:	Amends the California Voting Rights Act of 2001's definition of "political subdivision" to expressly include a charter city, charter county, or charter city and county. Specifies that it is the intent of the Legislature in enacting this bill to codify the holding of the state courts regarding the applicability of the California Voting Rights Act of 2001 to charter cities.

Requires that the boundary lines of each district be adjusted in accordance with specified provisions of existing law. Requires that the proposed boundaries satisfy specified criteria.

SUMMARY:	Authorizes a county elections official to account for ballots at the central counting place, to direct the precinct board to seal the ballots and to record certain information prior to the closing of the polls and to direct other elections officials to remove the sealed ballots prior to the closing of the polls and to deliver them to a receiving center or central counting place. Requires the county elections official, at least 48 hours before an election, to notify the public of the dates, times, and places to which ballot containers will be delivered. Requires the Secretary of State to adopt regulations addressing the secure delivery and transfer of ballots to a receiving center or central counting place.

SUMMARY:	Specifies that a person is guilty of a misdemeanor if he or she assumes, pretends, or implies by his or her campaign materials that he or she is the incumbent of a public office, or has been acting in the capacity of a public officer, when that is not the case.

AB 372 Elections: Write-In Candidates

STATUS:	05/06/2015 In Assembly Committee on Appropriations: Not heard.
CACEO POSITION:	Watch
SUMMARY:	Requires write-in candidates for a voter-nominated office who advance to the general election to pay the prescribed filing fee in order to appear on the general election ballot. Permits a candidate who alleges to be indigent and unable to pay the requisite fee to submit a statement of financial worth to the Secretary of State for consideration, and requires the Secretary of State to furnish the statement of financial worth to a candidate within a prescribed period and to determine whether a candidate who has submitted the statement is in fact indigent. Requires a candidate found not to be indigent to pay the filing fee within a prescribed time. Specifies that a candidate found to be indigent is not required to pay the fee to appear on the ballot.

SUMMARY:	Requires that a registrant provide proof of residence in order for a conditional voter registration to be deemed effective. Provides that if a conditional voter registration is not deemed effective, requires the elections official to process the affidavit of registration, and if all other eligibility requirements are met, requires the registration to be effective in forthcoming elections.

Provides the conditions under which a ballot may be counted if the envelope is not signed. Establishes procedures by which the Green Party would participate in a primary.
NOTE:	Incorporates additional changes to Section 3019 of the Elections Code, proposed by AB 1020, that would become operative only if AB 1020 and this bill are both chaptered and become effective on or before January 1, 2016, and this bill is chaptered last.

SUMMARY:	Makes a technical nonsubstantive change to existing law that authorizes a county central committee to be elected in each county at every presidential primary election.

SUMMARY:	Authorizes San Diego County, or any city, school district, community college district, special district, or other district or political subdivision whose boundaries are located wholly or in part within San Diego County, to conduct an all-mailed ballot special election or special consolidated election to fill a vacancy on the legislative or governing body of those entities, until January 1, 2021. Authorizes those entities to also hold an all-mailed ballot special election for county initiatives, city initiatives, district initiatives, bond issues, and school measures conducted pursuant to specified provisions. Extends the pilot program for San Diego County, as described above, until January 1, 2021. Requires certain voter education workshops to be conducted in-person.

CACEO POSITION:	Support
SUMMARY:	Requires the office of Superintendent of Public Instruction to be listed on the ballot under the heading, STATEWIDE EDUCATION, and it would move the location of this office on the ballot, thus changing the order of precedence. Removes other instructions relating to the placement of this office on the ballot.

<u>AB 609</u> Members of the Legislature: Residency

SUMMARY:	Permits a candidate for Member of the Legislature to file a statement with the Secretary of State in which the candidate voluntarily agrees that, if elected, he or she will continue to reside within the district from which he or she was elected during his or her term of office. Authorizes the Secretary of State to post on his or her Internet Web site voluntary statements of continuing residency filed with the secretary, as described.

SUMMARY:	Authorizes a county board of supervisors to require a new oath or affirmation to be filed within a specified time period of a legal change in name, delegated authority, or department by an officer or department head of that county. Authorizes the county to maintain a record, subject to disclosure under the California Public Records Act, of each person so required to file a new oath of office, indicating whether or not the person has complied. Specifies that failure to comply with this requirement for a new oath or affirmation is not punishable as a crime. Provides the procedure for taking away powers upon an officer's departure from office. Provides the oath requirement for a disaster worker and an appointed county deputy with a legal name change.

SUMMARY:	Renames the board as the Voting Accessibility Advisory Committee. Requires the committee to advise the Secretary of State on improving the accessibility of elections, including election materials, as specified, for all voters with disabilities, and revises the composition of the committee, as specified. Requires the Secretary of State to consult with the committee and consider the committee's recommendations, which the Secretary of State could implement at his or her discretion. Requires the committee to make additional recommendations to the Secretary of State for improving the accessibility of election materials made available over the Internet, as specified. Requires the elections materials made available over the Internet to conform to certain standards and guidelines, as specified. Requires the committee to make recommendations for providing voters with disabilities the same access and participation as is provided to other voters who are not disabled, including the ability to vote privately and independently.

SUMMARY:	Requires the Attorney General to include a specified title and summary if it is believed the measure would result in a constitutional right violation. Specifies that the statement does not count toward the 100-word limit and authorizes any elector to seek a writ of mandate challenging the inclusion of the statement.

SUMMARY:	Authorizes an elections official to send a voter a ballot by secure electronic transmission for an election conducted wholly within the county. Requires a voter who receives a ballot in this manner to print the ballot for return to the elections official.

<u>AB 952</u> Local Government: Vacancies

CACEO POSITION:	No Position
SUMMARY:	Provides that if the council fills a vacancy in an elective office by appointment, and that vacancy occurred in the first half of the term of office and at least 130 days prior to the next general municipal election, the person appointed to fill the vacancy holds office until the next general municipal election at which a person is elected to fill that vacancy, and thereafter, until the person elected is qualified. Provides that if the vacancy occurs in the first half of a term of office, but less than 130 days prior to the next general municipal election, or if the vacancy occurs in the second half of the term of office, the person appointed to fill the vacancy holds office for the unexpired term of the former incumbent.

SUMMARY:	Provides the minimum age to preregister to vote. Deletes provisions that allow county election officials to deputize as registrars qualified citizens to register voters anywhere within the county. Deletes provisions regarding the time period prior to an election in which affidavits of registration are accepted. Revises provisions governing the effective date for certain registration affidavits. Modifies the affidavit for registration, reregistration, or notification of registration transfer acceptance.
NOTE:	Incorporates additional changes to Sections 2150, 2208, and 2209 of the Elections Code, proposed by SB 589, that would become operative only if SB 589 and this bill are chaptered and become effective on or before January 1, 2016, and this bill is chaptered last. The bill would also incorporate additional changes to Section 3019 of the Elections Code, proposed by AB 477, that would become operative only if AB 477 and this bill are both chaptered and become effective on or before January 1, 2016, and this bill is chaptered last.

Requires the Secretary of State to present findings to specified committees of the Legislature no later than July 1, 2016. Repeals these provisions on January 1, 2017.

SUMMARY:	Makes technical, nonsubstantive changes to provisions of existing law that allows a voter, without loss of pay, to take off enough working time that, when added to the voting time available outside of working hours, will enable the voter to vote if he or she does not have sufficient time outside of working hours to vote at a statewide election, and provides that no more than two hours of the time taken off for voting shall be without loss of pay.

SUMMARY:	Makes nonsubstantive changes to provisions of existing law which makes it a crime for a person to commit or aid in fraud regarding the casting of a ballot in an election.

SUMMARY:	Requires an elections official to immediately place an initiative measure on the election ballot for which it qualifies if the official finds the petition to be sufficient, and if more than one election date is legally possible, the official would be required to place the measure on the ballot for the earliest legally possible date. Provides that this procedure would apply to municipal, county, and district initiative measures, including city and city and county charter proposals, and to municipal referendum measures.

Requires the Secretary of State to approve the law, regulation, or policy only if specified conditions are met, and provides that the law, regulation, or policy shall not take effect or be administered in the covered political subdivision until the law, regulation, or policy is approved by the Secretary of State except, as specified.

Requires the Secretary of State to consult with and consider the recommendations of the committee.

Requires the Secretary to notify the person that he or she is registered to vote unless they decline. Provides records shall constitute a completed affidavit of registration. Provides no action is to be taken for a person registered in such a manner who is not authorized to vote.
