**SB 439 (ALLEN) -SUPPORT**

Dear Senator Allen:

The California Association of Clerks and Elections Officials is pleased to advise you of our support for SB 439, which permits election officials to offer conditional voter registration and provisional voting at satellite locations on days other than Election Day. This expansion of the time window in which these options can be offered greatly extends opportunities for eligible voters to cast a ballot which will be counted.

This bill provides a great service to voters and removes one more barrier to voting at a time when voter participation is low.
