Dear Senator Pavley:

The California Association of Clerks and Election Officials Elections Legislative Committee has reviewed **SB 267** (as introduced February 12, 2013), that would require the local election official to establish precincts and polling places consisting solely of campuses of each local community college, California State University, University of California, and California Community Colleges within the county. The Committee appreciates the additional options for students, but would like to express the following concerns, which are the same as the Committee expressed with AB 346 (Atkins, 2011).

County elections officials understand the desire to ensure that college students have easy access to the ballot. However, establishing polling places on University, State College and community college campuses may create a host of other problems. We acknowledge that your proposal is limited to campuses where 1,000 students or more reside. However, some of the issues identified in the discussion of your bill include:

- ★ Difficulties relating to re-establishing new permanent precincts in the county consisting solely of University, State University and community college campuses, and solely of student voters. This may be an impossible task in counties where a large portion of college housing is not located on campus, or where they institute satellite housing. This situation exists in Monterey County with regards to California State University at Monterey Bay. They have recently developed new student housing in Fort Ord, miles away from where the main campus is located.
- ★ Increased voter confusion – large campuses may be required to have multiple precincts, creating confusion on campus as to which polling place is associated with the precinct their housing is located
- ★ Increased number of provisional ballots - students attending college but not registered to vote with a campus address will have to vote a provisional ballot
- ★ Long lines created by the increase in provisional voting. The issue of long lines will be exacerbated on college campuses with the lengthy gubernatorial general election ballot and during high turnout presidential elections.
- ★ Larger, physically confusing campuses where the voting room may be very difficult to locate and be far from available parking or public transportation. Many buildings on college campuses are not ADA compliant. Typically, the most physically accessible buildings are the college campus centers or libraries, located in the heart of campus and very far from student housing.

There are additional issues, such as, increased confusion when an election occurs at times when there temporarily are no students residing at the campus or the campus is closed; lack of available parking when campus is crowded; and, increased confusion for students

attending classes on campus but who are not residing in that precinct and are not eligible to vote on campus.

We believe that the most successful way to ensure that students are able to vote and have their ballot counted is to minimize confusion and increase voter outreach and education efforts. Working with the Administration of the higher education campus to increase outreach efforts on campus to assist students understand how to register and vote by mail is a better solution. For example, Monterey County Elections Department had a campus polling place at the California State University at Monterey Bay. This location proved to increase voter confusion and the use of provisional voting. Provisional ballots were either partially counted or were rejected as the student was not registered in the precinct or in the County where they attended college. The polling place required additional poll workers and the assistance of field staff to manage the crowds of students.

Working closely with the Dean of Student Affairs to generate campus announcements and send emails to the student body on the procedures and deadlines to register to vote and obtain a vote by mail ballot from their home county or state has proven successful for Monterey County. Election staff meet with campus personnel and student body members involved in voter registration efforts in the months leading up to the election to coordinate efforts. Beginning with messages about registering to vote, the Department develops language for the Dean to distribute to the student body via email and other on campus announcements. The messages continue throughout the early voting period and relate to deadlines to register and how to obtain a vote by mail ballot. On Election Day, the Department stations two election officials at the Student Center with a secure vote by mail ballot drop box and a Roster Index of Voters to accept ballots and direct students to their proper voting location within the County. This partnership began in 2009, after the extremely high foot traffic, increased student voter confusion and use of provisional ballots during the Presidential general election, and has shown to successfully educate voters reflecting that few students actually claim their temporary college residence as their voting domicile and are voting by mail.
